



Perform Web Query:

1. **User will enter Motor Carrier's SCAC Code and the SCAC Code of the Equipment Provider they wish to confirm the Motor Carrier's interchange status for.**
2. **Click on Generate Query.**
3. **Results of Query will be returned.**

Sample of Result Returned Showing Motor Carrier Not Approved for specific Equipment Provider shown below:

Transaction Code – LIW4NIQ – unique transaction code assigned to each query to database

MC/EP Transaction is NOT OK - This will indicate that the query returned a negative result.

Busters Trucking is valid for UIIA – indicates specific Motor Carrier's status (active/cancelled) in the UIIA. This is not the motor carrier's status with the Equipment Provider. This information is shown in the line above.

ABC Container Line is valid for UIIA – indicates Equipment Provider's status in the UIIA.

Busters Trucking does not meet requirements for ABC Container Line– indicates Motor Carrier Status with specific Equipment Provider.

Motor Carrier Company Profile Info – this will provide contact, address, phone, fax of motor carrier

Insurance Expiration – will indicate the expiration dates of the four primary insurance policies (auto, general, cargo & trailer interchange)
